

IGNITION INTERLOCK SENTENCE - INSTRUCTIONS FOR A DEFENDANT

*** Failure to Follow these Instructions May Result in a Warrant for Your Arrest ***

- You have been sentenced to **PROBATION** and **you will be paying** for ignition interlock out of your own pocket. You should report to probation today since you must have the ignition interlock device installed within **10** business days of sentencing. You may pick from any of the service centers below.
- You have been sentenced to **PROBATION** and **some or all of the cost** for ignition interlock was **waived by the court**. You should report to probation **today** since you must have the ignition interlock device installed within **10** business days of sentencing. You must contact probation officer **Larry Mattle (753-3226)** since probation will pick the service center and direct you regarding installation.
- You have been sentenced to a **CONDITIONAL DISCHARGE** and **you will be paying** for ignition interlock out of your own pocket. You must have the ignition interlock device installed within **10** business days of sentencing. **You may pick from any of the service centers listed below. There is no need to contact Probation prior to installation.** However, *once the ignition interlock device has been installed you must then notify either Larry Mattle (753-3226) or Guy Smith (753-3407) at Monroe County Probation and let them know that the device has been installed.* They will then give you any further instructions regarding compliance with the Court's order.
- You have been sentenced to a **CONDITIONAL DISCHARGE** and **some or all of the cost** for ignition interlock **was waived by the court**. You must call probation **today** since you must have the ignition interlock device installed within **10** business days of sentencing. You must contact probation officer **Guy Smith (753-3407)** because he will pick the service center and he will direct you regarding installation.
